



MEGA BIRTHDAY PARTY TERMS AND CONDITIONS

**Party Bookings**

A tentative booking will be held for 7 days at which point the booking system requires a \$150 deposit. Bookings can be made over the phone by calling 08 8366 2240, online at [www.megacourts.com.au](http://www.megacourts.com.au) or in person at our Mega Courts Indoor Sports centre.

You must complete the party booking form and return to us via email to [coops@megacourts.com.au](mailto:coops@megacourts.com.au) or in person at our Mega Courts reception. The form must be completed and submitted as part of your booking.

**Payment**

To complete your party booking you must pay a non-refundable \$150 deposit, at which point your MEGA PARTY will be reserved for you at an agreed date and time and invitations will be made available.

Payments can be made with a credit card, direct transfer to our account BSB 015-310 Account 3011-41739 with the reference BP & surname of organiser. We also accept cash deposits and EFTPOS at the Mega Courts centre reception.

**Party Confirmation & General Information**

Sneakers, runners, or multi-sport trainers are best. No spikes or cleated footwear allowed. Virtually any shoes used on hard courts are suitable for our synthetic turf. Socks must be worn on the inflatables at all times.

It is a condition of entry that no outside food or drink is brought into Mega Courts Indoor Sports except for birthday cakes, special dietary food or baby food that have been approved by reception.

Your guests should be advised to be at Mega Courts Indoor Sports 15 minutes prior to the commencement of your party. For example, if your party is for 10.30am, you should advise your guests to arrive by 10.15am. As the Birthday Host, you should arrive early to greet your guests

As there may be bookings that run after your party, it is important that we run things on schedule and on time. Your party table will be available to you for a total of one hour or half hour on the party day unless otherwise specified, commencing as per your party booking starting time.

**Cancellations**

Cancellation of any booking needs to be received by email or phone to management 5 days prior to the birthday party. Cancellations received within 48 hours of the event will incur a 100% cancellation fee of your deposit and any food and beverage arrangements which have been entered into.

**Service Inclusions**

We reserve an area in the café with adequate seating for children participating in the party activities, adults will also have reserved seating with each party booking.

All parties have a dedicated party Host for the duration of your event.

**Security and Insurance of your property**

Our Mega Courts staff will take every care with security and protection of your property whilst on the premise; however, we cannot accept liability for loss or damage of any item whilst on our premises.

**Party Booking Client Responsibility**

It is your responsibility to ensure that all guests who attend the party behave in an acceptable manner.
