### Bookings

Bookings can be made over the phone by calling 08 8366 2240 or in person at our Mega Courts Indoor Sports centre. You must complete the OSHC booking form and return to us via email to [jessica@megacourts.com.au](mailto:jessica@megacourts.com.au) or in person at our Mega Courts reception. The form must be completed and submitted as part of your booking.

### Payment

We will confirm your booking via return email and an invoice will be issued. You must confirm final numbers (students and adults) with us 5 days prior to your excursion at which time the invoice due must be paid in full.

Payments can be made with a credit card, direct transfer to our account BSB 015-310 Account 3011-41739 with the reference OSHC & name of your OSHC. We also accept cash or credit card payments at the Mega Courts centre reception.

### General Information

Sneakers, runners, or multi sport trainers are best. No spikes or cleated footwear allowed. Virtually any shoes used on hard courts are suitable for our synthetic turf.

If you are participating in our Inflatable Fun Zone area, you MUST remove all footwear, jewellery, watches and glasses and wear socks at all times.

It is a condition of entry that no commercial food or drink is brought into Mega Courts Indoor Sports except for special dietary food, recess or student lunches that have been approved at the time of booking.

You should arrive at Mega Courts Indoor Sports at least 15 minutes prior to the commencement of your activities to ensure large groups are organised into required activities.

As there may be bookings that run after your excursion, it is important that we run things on schedule and on time.

### Cancellations

Cancellation of any booking needs to be received in writing to Mega Courts Indoor Sports 5 days prior to the OSHC Excursion to not incur any cancellation fees. Cancellation of bookings with less than 5 days notice may incur a 50% cancellation fee of the full cost of the excursion and any food and beverage arrangements which have been entered into. If you choose to reschedule the booking with at least 5 days notice provided, Mega Courts Indoor Sports reserves the right to charge a suitable fee determined by management at the time.
